### San Luis Obispo College of Law Advisory Board 2025 Scholarship Information and Application

The San Luis Obispo College of Law Advisory Board announces that it will confer one **\$5,000 Scholarship to one San Luis Obispon College of Law (SLOCL) student** in 2025. Advisory Board Members, the local legal community, and other donors have contributed the funds to make this Award possible.

<u>Eligibility</u>: Only SLOCL students who have at least completed the Fall semester of their IL year or 2025 SLOCL graduates studying for the Bar Exam are eligible. The Scholarship award will be announced around the start of Fall Semester and the award will be applied toward the student's tuition bill for Fall Semester. Prior Advisory Board Scholarship recipients are not eligible to reapply. Applicants must be in good academic standing and will be evaluated based upon this academic standing and the information addressed in their personal statement.

<u>Selection Committee</u>: A Committee of SLOCL Advisory Board Members will review applications and recommend one Scholarship recipient. Committee members sign an oath of confidentiality and impartiality and will use the law school's mission statement to guide their decision-making. The Monterey College of Law Scholarship Committee, which has access to students' academic performance, has final approval authority.

#### To Apply:

- 1. Complete the attached Application Cover Sheet.
- 2. Attach to your Application Cover Sheet (A) a resume, including education, work experience (paid or unpaid), community service, volunteer work, and/or clinic experience, if any; (B) two current (from 2025) signed letters of recommendation on letterhead from non-relatives; and (C) a personal statement not to exceed 600 words addressing (a) why you decided to go to law school, (b) what challenges or other life experiences you have faced that impact your law school experience, (c) and what you hope to contribute to society and/or achieve after law school.
- Your application is confidential. Return the completed application (Cover Sheet plus attachments), via email to Campus Dean Erica Flores Baltodano at <u>ebaltodano@slolaw.org</u>. Your complete application must be received by 11:59 p.m. on Sunday, July 29. Incomplete or late applications will not be considered.
