

Hundreds of Hours of Urgently Needed Services Are Given Free or at Low Cost Each Year to Communities MCL Serves

MCL students, graduates, faculty, and staff support our local communities in dozens of ways. Hundreds of hours, valued at more than \$1,000,000, are given each year across MCL's four physical campus and online locations. The MCL community donates, coordinates volunteer and relief efforts, provides free or low-cost legal clinics (which are semester-long courses for students), and offers free or low-cost mediation services through the Mandell Gisnet Center.



As part of a coordinated emergency response, MCL students, graduates, staff, and faculty volunteered to provide legal assistance to families displaced and harmed by the 2023 flooding in Monterey County. Clinic Courses in Common Areas of Need Provide Communities with Critical Legal Services and Students with Practical Legal Experience, in English and Spanish

Clinical courses, in a wide variety of areas of law that significantly serve local residents, give MCL students practical training in court procedures and client interactions. MCL faculty supervise and mentor students in small group clinical settings, sharing decades of law practice knowledge and experience to help MCL graduates prepare for law practice.

MCL has also partnered with the People's Justice Project, California Rural Legal Assistance (CRLA), local district attorneys, probation departments, and public defenders, to provide a Clean Slate Clinic for residents of San Luis Obispo and neighboring counties, in which students assist dozens of community members per year in petitioning for expungement of criminal convictions hindering their access to employment, housing, and other benefits and opportunities. Faculty for the Clean Slate Clinic also hold in-person clinic days for hundreds of community members to receive these services, and students have the opportunity to participate in these service days.

MCL students in Bakersfield have worked with the Greater Bakersfield Legal Assistance (GBLA) organization to earn clinical experience. GBLA has been providing high quality legal services to Kern County's low-income and elderly since 1968. KCCL students assist GBLA as interns. Empire College of Law, MCL's newest campus, is expected to feature clinical opportunities for students, too.

MCL's Conflict Resolution Center Provides Courts and the Public With Much-Needed Dispute Resolution Services


Mediation is a form of alternative dispute resolution in which a neutral third person helps the parties reach a voluntary resolution of a dispute. Mediation is an informal, confidential, and flexible process in which the mediator helps the parties to understand the interests of everyone involved and explore and work towards options for resolution that may be preferable to litigation.

The Mandell Gisnet Center for Conflict Management (MGC) administers several court-directed mediation programs in partnership with the Superior Court of Monterey County. The Executive Director of the Mandell Gisnet Center also she serves as the ADR Administrator for Monterey Superior Court.

Students enrolled in the mediation practicum course, as well as experienced community mediators, mediate in small claims, landlord/tenant, animal control, and other neighbor disputes. In addition, MGC maintains a panel of local pro bono attorney mediators who mediate in larger lawsuits. All MCL students are introduced to mediation skills through the required Core Mediation course, which prepares them to mediate cases referred to MGC by the Court.



Several hundred mediations are conducted or facilitated each year in support of the community, both through Superior Court and private referrals.

MCL handles thousands of calls per year from people seeking services through the community legal clinics and/or the Mandell Gisnet Center for Conflict Management. Community members are assisted by clinical staff who schedule a clinic appointment, assign a matter to a mediator, or refer the client to private counsel or other local resources.
